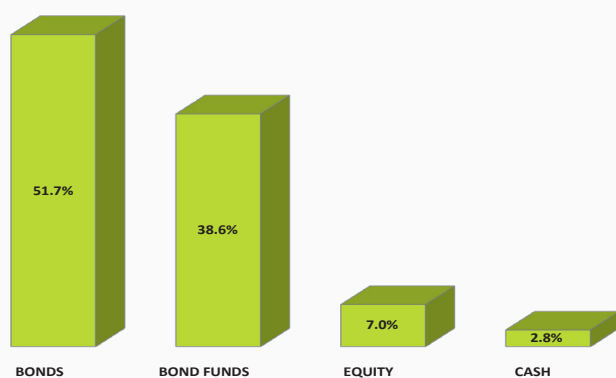
### Top 10 Funds



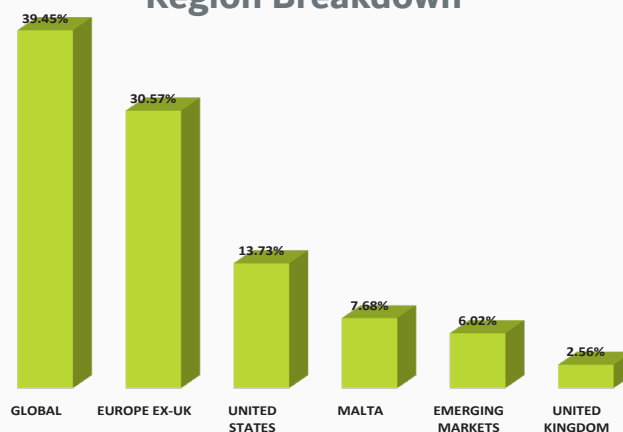
### Top 10 Bonds



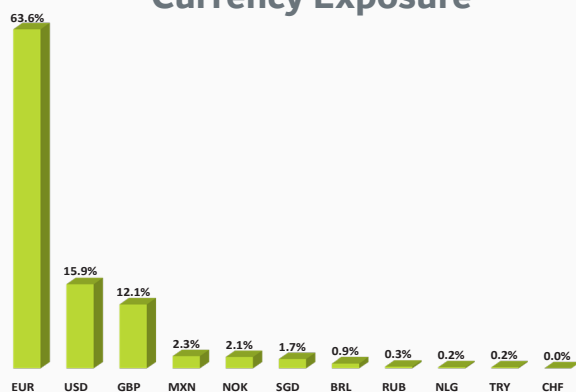
### Asset Class Breakdown
